IPM International Students Foreign Citizens through JIPMAT)

1. Admission Criteria

1.1. Eligibility

Qualifying Exam: Candidates should have passed 10+2/XII/HSC examination in arts/commerce/science stream or equivalent with 60% or more in the year 2024 or appearing in 2025. Candidates who are likely to complete standard XII/ HSC or equivalent by 31st July 2025 can also apply. The candidate must have passed the class 10th examination with 60% or more in the year 2022 or 2023.

The percentage of marks obtained by the candidate in Class X and Class XII would be calculated based on the Board's regulation. If there is no such regulation regarding aggregate marks from the concerned Board, then the aggregate marks of all the subjects that appear in the grade sheet should be considered for calculating the passing percentage.

The application of the candidates appearing in Class XII examination will be provisional until their Class XII results. The candidates who do not score the requisite score above will be considered to be out of the application/admission process.

Nationality: Only Foreign nationals are eligible to apply.

Age: Students of age 20 years or less on 1st August 2026 are eligible to apply. (born on or after 1st August 2005)

2. Selection Process

2.1. JIPMAT

The candidates are required to appear for the JIPMAT 2025 conducted by the National Testing Agency (NTA), India.

2.2. PI

The candidates, who scored* more than or equal to the overall and sectional cut-off, will be called to appear in the PI process (online mode).

* Sectional scores will be decided, before the PI shortlist, based on the available pool of candidates and JIPMAT score distribution.

2.3. Final Merit List

The final merit list be prepared as follows:

JIPMAT score: weightage – 50%; PI score: weightage – 50%

2.4. Tie-breaking rule for Merit List

If the overall composite scores of two or more students are found to be the same, then they will be ranked on the following basis.

- Overall Merit score (JIPMAT+PI) (higher score will be ranked higher),
- JIPMAT score (higher score will be ranked higher),
- Appearance in Class XII (recent appearance will be ranked higher),
- Appearance in Class X (recent appearance will be ranked higher),
- Date of Birth (younger candidates will be ranked higher).

3. Course Fee

Course Fee will be similar to the IPM 2025-27 batch (*Admission for Indian nationals through JIPMAT*). Medical Insurance, VISA, and other travel-related costs are to be paid by the students.

4. Offer Acceptance Process and Withdrawal

Detailed procedure for *Offer Acceptance* and *Withdrawal* will be informed at the time of Admission Offer.

Any dispute concerning Admissions for the IPM 2025-30 (Foreign Citizens) batch would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Bodh Gaya Only.
